Mutual Recognition Policy
 It was agreed that in the event of a member body has an issue (suspensions etc) the member body will notify the CCCA secretary, who will then notify all other member bodies, ACF and where applicable WCC.
ACF Member Bodies
 CVI – see agenda 9f, TFA NSWCFCA reported that member bodies could apply for an open show (to be decided by Management committee) some open shows already conducted. ANCATS reconfirmed ANCAT trained judges not accepted at this time, – they would need to be tested If they were applying to come to CCCA. Even if they were CCCA or ACF trained, they would most likely have to do refresher courses etc.
Breed Standards
 It was agreed by CCCA member bodies that before a new breed is accepted, the standard be discussed and agreed by both CCCA and ACF. This should lead to a more common approach to standards.
Registration policy
 No CCCA member body issues a new number to a cat –reaffirmed that its original number must be kept, with new bodies number added to end, if to long to add number the last number added to be deleted and new added to end.
Joint National Shows
 A straw poll was conducted as to whether member bodies would be in favour of the concept, yes – unanimous
 There are a lot of positives. Maybe they could be held every four years, however a lot more work would need to be done to reach a suitable solution as to differences for example CCCA hold a two day National show.
Health and Welfare
 The issue of DNA testing was discussed, it was generally agreed that where tests are available cats should be tested, however the ramifications of this would need to be considered before making mandatory.

Whilst ACF and some overseas countries do allow outcrosses CCCA have no allowable outcrosses.

If due to limited gene pool importation is considered only Full Generation or Generation 3 be allowed to be used with a full generation Sphynx When Generation 3 are imported they are to be placed on a Provisional register

DNA PARENTAGE ISSUE

QCI brought up the problem of how to register a litter with 2 sires or sire that wasn't expected

DNA testing is very reliable now if done by a registered vet under the CCCA protocol.

ie: all possible cats need to be microchipped, swabs and all paperwork and testing completed by a vet

Once the results are received, needs to be shown to a vet, or someone to be sure correct understanding is obtained of the report. Registrar needs to receive a copy of the results. If there is any doubt, the Registrar needs to consult with someone who can interpret

Motion: In the case of uncertain parentage of kittens, verification may be conducted using DNA testing. Testing must be conducted using the approved CCCA DNA collection Protocol.

Application for registration of the cat / kitten must be made to the registrar including a full copy of the DNA results. Should the registrar have any doubts as to whether the test supports the claimed parentage, he or she must consult with either the veterinarian who conducted the test or an independent expert in genetics

A possible protocol for Artificial Insemination in cats — ACF tabled the idea. Isobel Johnson and Julia Nicholls to work on the protocol. Both have accepted.

.Lesley Lyons discussed ethical breeding, how they are using DNA testing to see how they are breeding. Also concerned about the future of some breeds, organisations may need to consider outcrosses to help invigorate their lines – in Burmese, she said it was quite possible to mate them to the Singapura

She also talked about Manx breeding and how emphatic she was about not mating rumpie to rumpie

Anne Eckstein provided a report on the Feline Health Research Fund which was reported

A lot of time was spent discussing where FIFE notified WCC of a judge suspension – WCF picked up the judge concerned. An apology from WCF was provided. It was reiterated that all bodies are to recognise each other's expulsions etc.

12 Feline Health Research Fund

Guest speakers – Dr Carole Webb and Dr Kerry Fowler

- Carole and Kerry were invited to attend the Governing Council GM in April. They were asked to give the members an update on the status and future plans for the Feline Health Research Fund. From this presentation they have subsequently been invited to attend the Australian Cat Federation AGM in Adelaide in early June to present on the FHRF activities and hopefully garner further support
- Carole on behalf of the Trustees, expressed their gratitude to all those who donated to the FHRF in memory of Shirley Sargent and to John who suggested this.
- FHRF have appointed a new Secretary – Helen Radoslovich, thanks were given to Julia Nicholls for help in the appointment.
- As the administrative workload of the Fund increases, there is need to develop policies and procedures about how matters will be handled, how grants are to be tracked for progress and outcomes, asset registers etc. A new task currently being undertaken is the development of an Investment Strategy to ensure that the Funds attract the best interest rates
- The Fund is now receiving a good number of grant applications as awareness of its existence increases and due to the generosity of the cat world the funds available have also continued to grow. The FHRF assets total \$74,892.76 as at 31st March, 2013
- From the November round one new grant for a total of \$4600 and from the March round two new grants to a total of \$5000 have been funded and currently have two under review for consideration midyear. Current funded grants are
