INTRODUCING OUR JUDGES



DORTE KAAE (FIFe Denmark)

My love for cats started already as a child, where I grew up on a small farm with cows, horses, chickens, a dog and of course the cats. Once I saw a picture with a Siamese and I promised myself, that when I got my own home, then I would have a blue-eyed beauty like the one in the picture. I didn't stay with only one Siamese, so I soon started breeding Siamese and Oriental shorthair and during 35 years I have bred many lovely cats under my cattery name "Bellamis". I also had a beautiful red silver tabby Maine Coon neuter, which I showed together with my son. In my professional life, I work in a big IT company as a software tester. In this job I search for mistakes, but in my hobby – the cats, I look for beauty. I find myself very fortunate to see so many beautiful cats all over the world and I'm very grateful that you all come and let me see, touch and cuddle your lovely cats. My free time, when I'm not working or judging, is spent on my house and in my garden and I also like to do some exercise like running and walking in the nature. Further more I like going to the cinema watching movies, attending concerts or interesting lectures. I have 5 cats and they demand my daily attention, which I give them with great pleasure – I can't imagine living without cats. They give me so much joy and happiness. I have been in the cat world from when I got my first Siamese. For many years, I was in the Board of one of the Danish clubs and also the president in that club for a long period. In our main organization Fédération Internationale Féline - FIFe I have worked in the show commission and after that I was a member of the FIFe Board as the vice secretary for 12 years. My judging career started 28 years ago with Siamese/Oriental, and now I'm an all-breed FIFe judge spending many weekends judging – mainly in Europe, because FIFe has the most members there, but sometimes I also judge in Asia or South America. I can only go on such a long trip once a year, so in 2023 I'm very grateful being invited to judge in Australia. It's a great pleasure and honour for me – thank you for letting me see and judge your cats.



ELAINE GLEASON (CCA Canada)

I became involved in the cat fancy in 1981. In partnership with my husband, Bob, we have bred Burmese cats under the cattery name of 'Hullabaloo', retiring from breeding in the Spring of 2021. I remain active in clubs and at many levels within CCA. I have served in the past committee positions of Public Relations Chair, Chats Canada Cats Editor, Clerking Committee Chair, Board of Examiners Chair (Judges' Training) and I am currently the Standards Committee Chair. I am also a founding member of the Hamilton Cat Fanciers and PAWSitive PAWS Cat Club. I entered the CCA Judging program in 1984. I enjoy judging for CCA as well as foreign associations. My passion for judging has taken me to many places including France, Germany, South Africa, Russia, China, and Hong Kong.



ANNE HARVEY (TFA Tasmania)

Cats have always been part of Anne's family; however it was not until 1999 that she discovered the cat fancy. Beginning in the year 2000, Anne began breeding and showing Maine Coons. She was one of the first to introduce the breed to Queensland, and among the first handful of Maine Coon breeders in Australia at that time. Anne concentrated on health, temperament and quality in her breeding programme which produced some successful show winners and Cat of the Year winners during that time, but more importantly produced healthy well-balanced kittens who bring joy to their families. Although no longer breeding, Anne enjoys the companionship of her retired Maine Coons. Anne retired from work in 2015 which enables her to devote more time to the things she enjoys in life and to indulge her passion for travel. Anne recently moved from Hervey Bay in QLD to Evandale in Tasmania.



KAREN MOORE (GCCFASA)

Karen has been breeding and showing cats for the past 40 years under the prefix 'Euphoria'. Commencing with Burmese, which is still her main breed today, Karen has also had extensive experience in breeding Siamese, Orientals, Foreign White and Devon Rex cats, winning 8 NSW Cat of the Year Awards with these breeds. Karen has, over the years, imported both Burmese and Devon Rex from the UK to supplement Australian bloodlines. Karen is an international All Shorthair Judge and is a qualified Tutor Judge in all Shorthair Breeds. She is a life member of the Oriental Cat Club of NSW and a founding member and past President of the Rex Cat Club of NSW. Karen also breeds and races thoroughbred horses and is keenly interested in the racing bloodstock industry. Karen holds a degree in Psychology from the University of NSW and works in media and communications. Karen moved to South Australia in February 2017, buying a house on the beautiful southern coastline of Adelaide.



KIT FUNG (CFA Hong Kong)

Kit is a CFA Approved Allbreed Judge from Hong Kong. Kit registered Kit Cattery in 2006 and mainly breeds American Shorthair. His cattery obtained 3 NWs, 1 RW, 20+ DWs and 2 DMs. He obtained the first NW ASH which is registered in Asia Division. During Kit's breeding and showing career, he also used to show Manx, Oriental Longhair, British Shorthair, Exotic, Persian and Maine Coon in CFA. Moreover, he has been many places for his judging experience such as Asia, Europe, Japan and USA. Besides his hobby of breeding and showing cats, Kit also likes travelling, listening to music and playing sports.



ROBERT GLEASON (CCA Canada)

In August 1974, I entered my first pedigree cat, a Burmese, in the cat show at the Canadian National Exhibition (CNE) in Toronto, Ontario, which at that time was one of the largest cat shows in North America. My wife, Elaine, and I established Hullabaloo cattery shortly after our marriage in 1981. We have bred over forty CCA grands and over seventy regional and national winners including three CCA KOTY winners and an AOTY. We made the hard decision to cease breeding late in 2021. We are founding and still active members of the Hamilton Cat Fanciers and the Pawsitive Paws Cat Club (London, Ontario) both affiliated with the Canadian Cat Association (CCA). I was first elected to the CCA Board of Directors in 1983. I have served the association in many capacities including eight terms as President. I currently serve as Chair of the Legislative Committee and I am Past-Chair and active member of the Benefit Show Committee, in addition to responsibilities with our two home clubs. In 2003 I received my CCA Judging Licence. I have proudly represented the CCA internationally since the early 80's in my capacities as CCA President and as a CCA Judge. My experiences in France, Germany, South Africa, Russia, China, Hong Kong and United States have shown me that the cat fancy is a very special hobby. I am honoured to be coming to Australia.



DAVID SCADDEN (NZFC)

My wife Jacqui & I have been retired from the breeding game after breeding Birmans under the Magwai prefix since 1985. We both originate in the Wairarapa in the sunny South Eastern part of the North Island of New Zealand. We moved to Rotorua, in the Bay of Plenty in 2008. One of the major tourist destinations in the country, the scenery is striking and we are very central to other cities and beautiful destinations. Our other great love are our Bengals, which we originally imported into the country in 1996 and bred successfully under the LapLepid prefix. We have three children who have now left home and one grandson born in 2016. We have a number of desexed Birmans and Bengals to keep us pretty busy. Other interests include good wine, genealogy, music and collecting and restoring Ford Capri's. I started judging in 1992 and reached the status of All Breeds in 2005, learning a great deal about all aspects of felines along the way. EXHIBITOR INFORMATION - SPECIAL EXHIBITOR AND ENTRY REQUIREMENTS

MEMBERSHIP STATUS:

All exhibitors resident in NSW must be current financial members of NSWCFCA, except when the show is an Open Entry show where Cats NSW and ANCATS members may exhibit. New exhibitors resident in NSW may show three times as non-members provided their exhibits are registered in their name with NSWCFCA. An exhibitor resident in another state must be a member of a controlling body recognised by CCCA or ACF and the exhibits must be registered in the exhibitor's name with that controlling body.

ENTRIES:

All entries must be submitted on the current official NSWCFCA Entry Form (available from the NSWCFCA website) together with a clear copy of each exhibit's registration certificate in the name of the exhibitor as owner.

For interstate exhibitors where the registration certificate does not include a four generation pedigree, then a four generation pedigree must be provided showing the breeds and colours of all forebears.

All exhibits must conform to CCCA Breed Standards.

COMPLAINTS AND DISPUTES:

Show Procedure 1.3 requires that any dispute arising from any aspect of the conduct of a show shall be referred to the Show Committee of the show prior to the conclusion of the show.

RETURNED CHEQUES:

Should any cheque be returned unpaid, a bank cheque, money order, or EFT transfer will be required to ensure that the entry is processed, and the costs incurred by the club for the returned cheque shall be paid by the exhibitor.

AMENDMENTS TO SEX/COLOUR/TITLES:

Any change to the sex or colour/pattern or the title of an exhibit after an entry has been lodged must be submitted in writing to the Show Secretary together with a copy of the amended Certificate of Registration no later than one week prior to the show date unless arrangements have been made with the Show Secretary to provide the changes at a later date. No changes will be made to the catalogue or judging slips on the show day.

CLAWS TO BE CLIPPED:

The front and back claws of each exhibit must be clipped. Judges may class an exhibit as Not in Show Condition (NSC) when the claws are not adequately clipped.

VETERINARY INSPECTION:

Each exhibit must be inspected by and pass the Veterinary Officer's Inspection – REFER Point 13 – In Cage Vetting

VACCINATION OF KITTENS:

All kittens must be vaccinated and at least one vaccination must be administered by a qualified veterinary practitioner. Exhibitors must produce documentary evidence (valid vaccination certificate signed by a qualified vet) for each kitten, and a vaccination shall have been carried out not less than 14 days prior to the date of the show. Failure to produce a valid vaccination certificate at vetting may result in a single vet out for the kitten concerned. (See also Show Procedure 6.3 c).

VACCINATION OF CATS:

Clause 6.3 of NSWCFCA Show Procedures relating to vaccination requirements for exhibits over 9 months has been updated. All cats (ie exhibits 9 months and over) must have had a Feline 3 vaccination administered within a period of not more than 3 years prior to the date of the show. This is a minimum requirement.

AGGRESSIVE EXHIBITS:

A Judge or Steward is not required to handle any exhibit showing signs of aggression. Owners have a duty of care not to bench any exhibit that has a reported history of fractious behaviour. The Show Manager in consultation with the Show Representative may request the removal of any such exhibit from the show.

NSWCFCA CAT/KITTEN OF THE YEAR AWARDS:

To be eligible for Cat of the Year award a cat must be in the continuous ownership of a NSWCFCA financial member throughout the year. Points are awarded based on the Top Five results at a show – 1st-10pts; 2nd- 7pts; 3rd- 4pts; 4th- 2pts; 5th- 1pt.

Note 1. Where an owner becomes a member after the start of a calendar year, points will only accumulate from the date the membership application is processed by the NSW CFA Office.

Note 2. If during the year a cat is transferred to a new owner who is not a member, the cat's ownership by a financial member will be deemed continuous provided a membership application from the new owner is received and recorded by the NSW CFA Office within 4 weeks of the date of transfer, otherwise note 1 shall apply.

Note 3. Where an interstate, Cats NSW, or ANCATS exhibit gains a Top Five placing, then that placing remains awarded to that exhibit and the placing of NSW CFA exhibits is not altered.
