#### NANCY DODDS (CFA USA)

was accepted into the CFA judging program in 1978. Today I am an approved Allbreed judge.

I have bred and shown Persians, Siamese and Cornish Rex. I am still an active breeder of National winning Cornish Rex. In recent years I have attained CFA National Winner (NW) status on several of my Cornish Rex. I am a file administrator in the CFA Judging Program Committee, shepherding trainees and advancing judges through the judging program in their journey to

I have been a mentor and training judge for many trainees in the CFA Judging Program.

I am retired from a management position in the Banking Industry in the United States. I have been active in nonprofit organizations in my community.

I have been a member of several cat clubs and I am currently active in the largest CFA Club in Arizona. Phoenix Feline Fanciers

I have served as a board member. President and Secretary for this club. I am also currently the Vice President of this club.



#### DR NIKKI CRANDALL - SEIBERT (TICA USA)

Nikki (with her then future husband, Cory) started showing Japanese Bobtails in 1989, although in a different cat association. Japanese Bobtails are very addictive and so so they found themselves breeding cats. Their first litter was born on June 12, 1991 and Rockinashi Japanese Bobtails was established. Based on a love of "silver" Japanese Bobtails, they later partnered with Jennifer Reding (California) and established Ginchika Japanese Bobtails. Although very successful in the other association, in 2006 Nikki & Cory began showing in TICA. Nikki immediately immersed herself in TICA, first by ring clerking and then master clerking. With her background of coordinating cat shows, she quickly found herself embraced by TICA clubs and helping with shows.

Nikki and Cory continued to produce beautiful cats and yearly Regional Wins were the norm for them. But they also were interested in other breeds and so, in addition to Japanese Bobtails, they have shown Somalis, Birmans, Himalayans, Maine Coons, Norwegian Forest Cats, Siberians, Oriental Shorthairs, Household Pets, and Khaoman However, Japanese Bobtails continue to be their heart breed.

In 1995 Nikki graduated from the School of Veterinary Medicine, University of Wisconsin (Madison) with her DVM degree. Again due to her love of cats, over the years she frequently " specialized" in feline care. With her love of knowledge, Nikki also learned acupuncture (for animals) and continues to learn more about "natural" ways of healing. What has remained constant is her love for cats, her love of showing cats, her knowledge of cats, and her ability to handle cats, so it was no surprise when Nikki applied to TICA's judging program. Nikki was accepted into TICA's judging program on 8/20/14, and her first judging assignment was in Waukesha, WI on 9/6/14. She was then advanced to All Breed in January of 2018. If you ever watch Nikki as she judges, it soon becomes evident that this is where she belongs ... she loves the cats, she loves handling the cats, she

I have judged in New Zealand, Australia, and China.

I have moved from Sydney to Adelaide and am a member of GCCFSA. I have lived in Australia twice before, in 1984-1985, and again in 2010- 2012, after the Canterbury earthquakes, and now have decided to make Australia my home once again.

I returned to New Zealand in 2012 and applied to re-join the NZCF judging fraternity. In 2015 I was elected to the Executive Council. I held the following Portfolios: Judges, IT, and Registrations. I ended my three-year tenure also holding the Vice Chair position.

Over the past 30 plus years I have been involved in all the various aspects of the Cat World, breeding, judging, Club committees and running cat shows. Most recently as part of the Executive for CATS NSW prior to my move to South Australia.

In my other life, I have worked as an HSSEQ Advisor, Chef, Bus and Forklift Driver, and also a Lab Technician. I have travelled over most of NZ, been to Fiji, USA,



#### DR JOCENE VALLACK (QFA)

Dr Jocene Vallack works in Education and has been breeding cats since 1998. Initially a Siamese and Oriental breeder, she raised Foreign Whites and Black Orientals, and later progressed to Silver Classic Orientals.

Around 2010, Jocene had privileged access to some lovely USA Bengal lines and she still loves this breed.

Jocene became interested in Sphynx cats about ten years ago, and now breeds them exclusively. As a result of working in collaboration with overseas

breeders, her Alchemy Sphynx Cats have pure lines, imported from Russia, UK and New Zealand.

After many years as a Steward and Show Committee member and Manager in Melbourne, she began her judge's training and examinations in Victoria in 2011 with the FCCV. Later, after moving to Queensland for work, she was invited to complete her Shorthair training through the FCCQ. She remains

indebted to each of these affiliations for their expertise and mentoring. Jocene now resides in Mackay, where her cats enjoy their shady enclosures in the subtropical climate.



#### **DENNIS GANOE (CFA USA)**

I first went to a cat show in the summer of 1987 as an assistant to carry cats into the show hall. At my first show I discovered the Korat and fell in love with the breed. I got my own cats that fall from a Korat breeder, Judy Buckle. Judy and I traveled to local shows as I learned more about cats and showing. On our way to a show, I proposed, and we married in 1990. During the next ten years, I learned to clerk, how to run a cat show and raised and exhibited Persians and Maine Coons in addition to Korats. I've also exhibited Orientals, Abyssinians, Scottish Folds, Exotics and Somali. I have since raised Bengals and LaPerms. Just this year we acquired our first Khao Manee.

In 2000 I applied and was accepted into the CFA judging program, advancing through the ranks to become certified all breeds in 2007. I've recently celebrated my 22nd year as a CFA judge. I am the current Breed Council Secretary for LaPerms. I was elected to the CFA Board of Directors in 2013 serving for two years

I've judged in Japan, Europe, Thailand, Malaysia, Indonesia, and China under CFA rules. I've also judged in South Africa (under SACC rules) and Australia (under ACF rules) Everywhere I've traveled I have had the great pleasure to share my love of cats with like minded people. It continues to be a joy for me



#### **GRANT LEIH** (SACC South Africa)

Breeding and showing fell into my lap by accident in 2003, but soon became my passion that continues to this day. My draw always veered towards a specific breed's personality rather than its aesthetics. Though this changed dramatically after training to become an all-breeds judge. Along this journey I developed an affiliation for the different and unusual. As such my main focus has always been the LaPerm but I have also bred American Curl, Selkirk Rex, Cornish Rex, Scottish Fold. I was a founder member of one of the largest and most successful breed groups that have run some of the largest shows in South Africa for a number of years. Including having 32 Sphynx, 14 LaPerms and over 20 Cornish Rex on one show, an achievement our committee is very proud of considering the small cat fancy in South Africa. Shows are dedicated to the education and promotion of the Rex breeds as well as those who have mutations that affect the coat such as the Sphynx and Peterbald; but also with a strong drive for charity and the care & protection of all felines. My journey towards becoming an all breeds judge began in 2006 and took 12 1/2 years to complete. I have been in involved in mentoring many new people to the cat fancy, as well having a lot of involved in tutoring new, young and upcoming judges.



#### **DAVID COLLEY (NZCF)**

I have been involved in NZCF since 1998, when we purchased our first Pedigree kitten, a Cornish Rex Kitten which we showed in 1999. By 2000 we went to Sydney and purchased some Cornish Rex cats from Eula Cross and started Breeding them which we really enjoyed. They are real fun and so active. We then started breeding Russian Blues in 2006, with again buying breeding stock from Australia. These are such loving and loyal cats, with a fantastic nature. We still breed Russians and we have just recently gone back into breeding the Cornish Rex our first litter due within a month. During 2003 – 2005 I trained as a Shorthaired Cat judge, and since then have judged throughout NZ, which is a real honour and twice in Australia, both times for ACF at their National Shows – 2017 in Brisbane and 2023 in Launceston. I have spent 2 – 3 year terms on the Executive Council and 2 years as Chairperson before not standing again for re-election last April. I will be coming from NZ but I am from Australia, having moved to NZ when I was only 19 years old. I spent 3 years in Inverell including my first year in High School and then did 5 years at Kempsey High School back in the 1970's. So, I will be glad to see over some old tramping grounds from way back. Really looking forward to seeing some wonderful Russians and catching up with you all.



#### TROY WILLEMS (FCCV)

In 2005, my life took an exciting turn when I stumbled upon an article about Bengal cats. The concept of these domesticated hybrids with Asian Leopard Cat lineage instantly captivated me. Following extensive research, I knew I had to introduce these magnificent felines into my life. In early 2006, I joined the FCCV as a breeder, operating under the Voodoocatz prefix, and soon acquired my first breeding pair.

My journey into the world of cat shows began in late 2006, showcasing my first male. Although he was not suited for the show bench, I persevered and found success with my home-bred show cat, Voodoocatz Khanji. Khanji possessed the perfect temperament and thoroughly enjoyed every aspect of the show circuit, eventually achieving the prestigious titles of CCCA Champion and Emerald Grand Champion.

Alongside my involvement as a breeder and exhibitor. I delyed into the world of cat stewardship with the FCCV, where I had the privilege of working with esteemed domestic and international judges. An exciting opportunity to undertake the Group 2 & 3 judge's courses presented itself, and I eagerly embraced the challenge. I successfully obtained my open judging license for Groups 2 & 3 in January 2017, and I relish the opportunity to evaluate short-haired cats at events nationwide During 2023 I took my judging knowledge to the next level to become an all breeds judge and successfully completed my Group 1 judging licence requirements. As a newly appointed All Breeds Judge with the FCCV I'm excited to continue my career across local, interstate, and international assignments My journey from a childhood surrounded by beloved family pets to a dedicated judge in the world of feline beauty and grace has been a remarkable and fulfilling

I started breeding Colourpoints about 20 years ago under the OZKI Prefix with Linda. We then moved on to Persians and Exotic tabbies, bi-colours, chocolates and vans with success. ## NSW CAT FANCIERS' ASSOCIATION INC EXHIBITOR INFORMATION - SPECIAL EXHIBITOR AND ENTRY REQUIREMENTS

**MEMBERSHIP STATUS:** All exhibitors resident in NSW must be current financial members of NSWCFA, except when the show is an Open Entry show where Cats NSW and ANCATS members may exhibit. New exhibitors resident in NSW may show three times as non-members provided their exhibits are registered in their name with NSWCFA. An exhibitor resident in another state must be a member of a controlling body recognised by CCCA or ACF and the exhibits must be registered in the exhibitor's name with that controlling body.

**ENTRIES:** All entries must be submitted on the - www.catsonline.com - portal, together with a clear copy of each exhibit's registration certificate in the name of the exhibitor as owner plus vaccination record. For interstate exhibitors where the registration certificate does not include a fourgeneration pedigree, then a fourgeneration pedigree must be provided showing the breeds and colours of all forebears. All exhibits must conform to CCCA Breed Standards.

**COMPLAINTS AND DISPUTES:** Show Procedure 1.3 requires that any dispute arising from any aspect of the conduct of a show shall be referred to the Show Committee of the show prior to the conclusion of the show.

**AMENDMENTS TO SEX/COLOUR/TITLES:** Any change to the sex or colour/pattern or the title of an exhibit after an entry has been lodged must be submitted in writing to the Show Secretary together with a copy of the amended Certificate of Registration no later than one week prior to the show date unless arrangements have been made with the Show Secretary to provide the changes at a later date.

**CLAWS TO BE CLIPPED:** The front and back claws of each exhibit must be clipped. Judges may class an exhibit as Not in Show Condition (NSC) when the claws are not adequately clipped.

**VETERINARY INSPECTION:** Each exhibit must be inspected by and pass the Veterinary Officer's Inspection – REFER Point 13 – In Line Vetting.

**VACCINATION OF KITTENS:** All kittens must be vaccinated and at least one vaccination must be administered by a qualified veterinary practitioner. Exhibitors must produce documentary evidence (valid vaccination certificate signed by a qualified vet) for each kitten, and a vaccination shall have been carried out not less than 14 days prior to the date of the show. Failure to produce a valid vaccination certificate at vetting may result in a single vet out for the kitten concerned. (See also Show Procedure 6.3 c).

**VACCINATION OF CATS:** Clause 6.3 of NSWCFA Show Procedures relating to vaccination requirements for exhibits over 9 months has been updated. All cats (ie exhibits 9 months and over) must have had a Feline 3 vaccination administered within a period of not more than 3 years prior to the date of the show. This is a minimum requirement. Exhibitors must produce documentary evidence (valid vaccination certificate signed by a qualified vet) for each cat.

**AGGRESSIVE EXHIBITS:** A Judge or Steward is not required to handle any exhibit showing signs of aggression. Owners have a duty of care not to bench any exhibit that has a reported history of fractious behaviour. The Show Manager in consultation with the Show Representative may request the removal of any such exhibit from the show.

**NSWCFA CAT/KITTEN OF THE YEAR AWARDS:** To be eligible for Cat of the Year award a cat must be in the continuous ownership of a NSWCFA financial member throughout the year. Points are awarded based on the Top Five results at a show – 1st-10pts; 2nd – 7pts; 3rd - 4pts; 4th – 2pts; 5th – 1pt.

**Note 1.** Where an owner becomes a member after the start of a calendar year, points will only accumulate from the date the membership application is processed by the NSW CFA Office.

**Note 2.** If during the year a cat is transferred to a new owner who is not a member , the cat's ownership by a financial member will be deemed continuous provided a membership application from the new owner is received and recorded by the NSW CFA Office within 4 weeks of the date of transfer, otherwise note 1 shall apply.

**Note 3.** Where an interstate, Cats NSW, or ANCATS exhibit gains a Top Five placing, then that placing remains awarded to that exhibit and the placing of NSW CFA exhibits is not altered.
