**NSWCFA propose changes to the Persian breed Standard**

- (1) Proposal 1: that CCCA changes the current description of the undercoat for the Golden Persian to include the word apricot: ie rich warm cream to apricot.
- (2) Proposal 2: that CCCA recognizes the origin of the Persian breed and accepts the Blue Golden (in both Chinchilla and Shaded varieties) as recognised colours/patterns.
- (3) Proposal 3: that CCCA recognizes the origin of the Persian breed standard and accepts Blue Silver (Chinchilla and Shaded) (Blue-Green eyes) and adds - to the existing Blue Pewter classification, the category of Black Pewter with the allowance of copper eye colour.
- (4) Proposal 4: that CCCA recognizes the origin of the Persian breed standard and accepts the Golden Tabby in all colour variations presently accepted for the Black Silver Tabby – with green/blue-green eye colour only, ie not Copper eye colour.
